



Notice to the market

Joinville, October 1, 2020 - Tupy S.A. ("Company", B3: TUPY3), comes to present to its shareholders and the market in general the clarifications requested by the *Superintendência de Listagem e Supervisão de Emissores* (literally translated as: Superintendence of Listing and Supervision of Issuers) of B3, through the Official Letter B3 789/2020-SLS, issued on September 30, 2020 ("Official Letter"). The letter makes reference to the atypical stock movement and thus provides:

"Dear sir,

In view of the latest fluctuations recorded with the shares issued by this company, the number of trades and the amount traded, as shown below, we are requesting that you inform, by 10/1/2020, if there is any fact that you are aware of that can justify such event.
